# Dear Leaders & Supporters of CED in South Carolina,

2023 brought a year of change and growth in the community economic development industry (CED) in South Carolina. Highlighted by numerous achievements and successes that you will read about throughout this report, 2023 saw the realization of years of hard work and steadfast commitment from CED supporters like you. Thanks to the resilient support of CED advocates, funders, and policy makers, the CED industry continued to make a positive impact on low-wealth communities across South Carolina. Keeping grassroots organizations and marginalized communities at the forefront of our mission, the CED agenda made strides in 2023, placing the industry in a position to continually build momentum and close the gap for those left out of the economic mainstream.

- \$3 million in available Community Development Tax Credits leveraged over \$7.5 million in private investment to certified CDCs and CDFIs from 2021-2023.
- \$2.7 million in grants were awarded from the Community Economic Development (CED) Fund to 14 certified CDCs and CDFIs.
- In partnership with The South Carolina Office of Rural Health and SC Department of Health and Environmental Control (DHEC), SCACED provided grant funds for the creation or growth of 15 community gardens and 6 hoop houses as a strategy to mitigate food deserts and impact health disparities in South Carolina.
- The SBA-funded South Carolina Community Navigator Pilot Program successfully completed its two-year term facilitating over \$27 million in approved loans and grants and over 4,000 hours of assistance provided to small businesses.
- The South Carolina Electric Cooperative Empowerment Program launched to provide rural communities with the knowledge and tools to elevate their voices within their local cooperatives and run for the Board of Trustees.
- The 2023 Community Capital Conference and Opportunity SC: 2023 convened nearly 500 dedicated community developers and leaders to reconnect and learn about creative community development financing tools, healthy food networks and policies, and strategies for continued growth in rural communities, community development corporations, and small and micro businesses.

These are but a few examples of the tremendous successes of the CED sector in South Carolina in 2023. None of our success would have been possible without the support of our funders, members, partners and you, the leaders in the CED industry. To learn more, we invite you to review our 2023 Annual Report. Here you will learn about the progress and impact of the CED industry, which is playing a significant role in helping our state transform into a beacon of resiliency and prosperity. ## **Community Development Tax Credit Impact**

The South Carolina Community Development Tax Credits support Community Development organizations across South Carolina who are providing access to rental and homeownership, small business lending and technical assistance, workforce development, financial literacy, and home preservation.

Tax Credits, provided to South Carolina taxpayers, for all Equity Investments are 33% of the Equity Investment Amount and Tax Credits for all Cash Donations are 50% of the Donation amount.

#### H.4118: Reauthorize Community Development Tax Credits

We encourage the South Carolina General Assembly to allocate \$3 million annually for South Carolina Community Development Tax Credits for five years to support Community Development organizations across South Carolina.

#### Advocate for Anti-Predatory Lending Legislation

As part of the SC Fair Lending Alliance, we advocate for legislation designed to implement more stringent regulations on payday and installment lenders, specifically addressing unlawful trade practices within this sector in South Carolina.

#### Advancing SC Housing's Trust Fund Home Repair Program

### Community Navigator Pilot Program

Established by the American Rescue Plan Act of 2021, the Small Business Administration's (SBA) Community Navigator Program (CNPP) utilizes a "hub and spoke" model to help small businesses, with a focus on those owned by veterans, women, and socially and economically disadvantaged individuals - including in both rural and urban communities. Announced in Fall 2021, SCACED received a \$2.5 million grant to serve as the "Hub" organization for South Carolina, working at the center of a network of 8 "Spoke" organizations across the state who deploy business resource professionals to work with small businesses during economic recovery.

#### Success Story: Diaz Mobile Detail and Tint Service

Victor Diaz started his mobile detailing and tinting service in 2018 with one truck and a set of equipment. His business flourished during the COVID-19 pandemic because of the mobility of the company's services, and he soon realized he needed to expand with another truck and equipment. After taking entrepreneurship courses with the SC Hispanic Chamber of Commerce, Mr. Diaz decided to enroll in the SC Community Navigator Pilot Program to receive help navigating the company's next steps.

Through the Navigator Program, Mr. Diaz and his wife Sandra worked with Lee McElveen of the SC Hispanic Chamber to develop a business plan and obtain status as a veteranowned certified business. These tools put Mr. Diaz in a position to apply for loans and make the expansions necessary to grow his business.

Being part of the Navigation Program has been a tremendous opportunity," said Diaz. "Mrs. McElveen made us believe in ourselves and provide the push we needed to apply for our first contract. Our business has been greatly helped by this program and we tell every Hispanic business owner about it."

### FUNDING PROGRAMS

### **Community Economic Development Fund**

The Community Economic Development Fund is appropriated state funding to support state certified CDCs and CDFIs whose primary function is to develop projects and activities that enhance economic opportunities and wealth creation in economically challenged communities.

> The 2022 grant period closed in May 2023. The results from this period include: \$975,000 granted to 11 Certified Organizations leveraged \$14.8M in funds

#### **\$75,000-Affordable Housing** (North Charleston, SC) Metanoia CDC

Carolyn and James Lecque approached Metanoia about partnering to develop the Golden Dream Townhomes on family-owned property. The Lecque Family has a long history of providing affordable rental housing in Liberty Hill, and this project continues that tradition in a community facing rapid gentrification. Two buildings house eight affordable apartments ranging in size from 1-3 bedrooms. The Lecque Family will continue to own the property with the support of Metanoia who built the homes and will manage the property for decades to come.

#### \$150,000-Small Business Support and Lending (Irmo, SC) **CommunityWorks**

Jarvis O'Neal Adams, the entrepreneur behind O'Neal On Time Recovery & Towing, LLC, based in Irmo, SC. Starting a towing business was a dream for Jarvis, nurtured through 18 years of experience in the industry. However, every dream comes with challenges. Some of the major hurdles were establishing a brand identity, gaining recognition through their collaboration with the CommunityWorks team, Jarvis received invaluable guidance and financial assistance. CommunityWorks provided a loan that enabled Jarvis to buy a rollback tow truck to expand his business.

#### Success Story: Grace Impact Development Center's Jefferson Mobile Welding Lab

Grace Impact Development Center's (GIDC) Jefferson mobile Welding Lab, launched in May 2023, was developed by retrofitting a conex container into a mobile welding training unit. The unit has four welding stations and the workforce development program is led by retired master welders. It is a five-month program where up to 10 students learn the basics of mig and stick welding and are prepared for certification with one of GIDC's welding industry partners. Funding from the CIF grant will support a cycle of training in the underserved Cross area of Berkeley County.



SCACED partnered with USDA Natural Resource Conservation Service (NRCS) in their South Carolina Food Connection Community Gardens Project to support the creation and growth of community gardens and hoop houses in food insecure areas and among high-risk and underserved populations,
